



INVITATION FOR NOMINATIONS TO APPOINT MEMBERS OF APPEAL PANEL FOR DESTEA

1. The MEC for Economic, Small Business Development, Tourism and Environmental Affairs, Mr. M. Mohale, hereby invites nominations for the appointment of three (3) members of the Appeal Panel in terms of Section 43 of the National Environmental Management Act, 1998 (NEMA). The appointment will be for a period of **one (1) year** starting from the date of appointment.
2. Nominations are invited from persons with experience and knowledge (must have a relevant qualification and/or experience) in the following areas:

An Advocate, Attorney and/or A qualified environmental Practitioner practicing in the Republic of South Africa. Such Practitioner must have, for a cumulative period of at least three years after having so practised performed services relating to the application or administration of the law. Preference will be given to those who has exposure in the field of Environmental Law; and detailed knowledge on the following Acts:

- (a) Environment Conservation Act, 1989 (Act 73 of 1989);
- (b) National Environmental Management Act, 1998 (Act 107 of 1998);
- (c) National Environmental Management: Biodiversity Act, 2004 (Act 10 of 2004);
- (d) National Environmental Management: Air Quality Act, 2004 (Act 39 of 2004); or
- (e) National Environmental Management: Waste Act, 2008 (Act 59 of 2008), and

Subordinate legislation made in terms of any of these Acts.

Their functions will be to advise Appeal Authority: MEC on all appeals in terms of Specific Environmental Management Act. All nominations must be:

- (a) In writing and
- (b) Be accompanied by a detailed *Curriculum Vitae* of the nominee from which it could be determined that he/she meets the requirements as indicated above, motivation for appointment, certified copies of identity document and qualifications;
- (c) Be accompanied by a letter of acceptance of nomination by the nominee.
